Permitted file types:	Slideshow (PPT, PPTX) for candidate evidence; video file (AVI, M4V, MP4, MOV, or WEBM) for teacher-submitted group performance

The candidate is required to act with, and react to, another actor using a combination of drama techniques in a scripted role, for a live audience.

The scripted role may be from an existing script, or from devised work that has resulted in a written script.

The performance may be from a rehearsal, but must be script-down (that is, the performers must have learned their lines). The performance may be directed by a teacher, tutor, or senior student.

Use of costume items or props is not required, but may assist the candidate in performing a role. Use of technology that may hinder visibility of the candidate should be avoided.

The evidence submitted should include 3–4 minutes of video from the performance. The evidence may include two separate excerpts from the same performance event (that is, no more than one edit is allowed within a candidate's evidence). Note that evidence in excess of the 4-minute limit will not be considered for assessment.

In the video, the candidate and other actors in the performance must be clearly visible at all times in the frame. (The audience does not need to be visible.)

The candidate is also required to present a brief statement of intention, either in writing (70–100 words) or as an audio recording (no more than 1 minute in duration). The statement of intention must include reference to:

- the role (noting relationships to other characters on stage or mentioned in dialogue)
- the place
- the situation.

Submission requirements

Individual candidate evidence is to be submitted as a slideshow (PPT, PPTX) containing three slides:

1. Details of the candidate and performance.
2. The candidate's statement of intention.
3. Video evidence of the candidate's performance.

The submitted slideshow must be entirely self-contained – it must not include links to content outside of the submission (e.g. a link that takes the assessor to a YouTube video or a file in Google Drive). Any such linked content will not be considered for assessment.

In the case that the teacher wishes to submit a single group performance by multiple candidates, this is to be submitted as a video file (AVI, M4V, MP4, MOV, WEBM).

The maximum file size that may be submitted is 5GB. *Note that only the specified file types may be submitted, and that other file types may not be able to be marked.*

Slide 2

The slide should present the candidate's statement of intention, either in writing (70–100 words) or as an embedded audio file (MP3 or WMA, no more than 1 minute in duration).

Slide 3

The third slide should include either:

- a single embedded video file (AVI, M4V, MP4, MOV, or WEBM format, no more than 4 minutes in duration) of the candidate's performance; or
- (if the teacher has chosen to submit a group performance by multiple candidates) an indication of the start- and end-time of the candidate's performance. (The following table may be used as a template.)

Permitted file types:	Slideshow (PPT, PPTX); and only if necessary, audio files (MP3, WMA) and video files (AVI, M4V, MP4, MOV, WEBM).

In response to the task below, the candidate will submit a report on their response to a drama performance that they have participated in or viewed as a member of the audience during the year of the assessment.

The drama performance may be solo or ensemble. It may be a full performance or an extract (e.g. a scene). A viewed performance may be either a live performance or a recorded performance intended for a live audience.

TASK

Respond to a drama performance, with a personal connection to the wairua of the performance, by addressing the following questions.

- How and why did the key message(s) of the drama performance have an effect on the audience? Why was this important?
- How and why were a range of drama components used to create effect in the performance?

Note: Drama components include techniques, elements, conventions, and technologies.

- How and why did the wairua of the performance have an impact on you? You should consider your personal connection to:
 - the relationship between performers and audience
 - the intended effect of the performance on the audience
 - your personal response to the performance.

DEFINITIONS

Elements include role, time, place, situation, action, tension, mood, contrast, focus, and symbol.

Techniques include the use of:

- voice (e.g. pitch, pace, pause, inflection, tone, volume, breathing)
- body (e.g. gesture, posture, body awareness, eye contact, facial expression)
- movement (e.g. timing, direction, energy)
- space (e.g. levels, personal, general).

Conventions involve ways of working in drama / theatre that explore meaning or deepen understanding, or are established practices. They could include, but are not limited to:

- aside
- entrances and exits
- flashback and flash-forward
- narration
- slow motion
- soundscape
- split focus
- split stage
- spoken thoughts
- stage directions
- still image
- telephone conversations.

Technologies include sound, lighting, set, costume, properties, digital projection, set design, special effects, and make-up.

Submission requirements

The report should be submitted as a slideshow (PPT, PPTX) containing an introductory slide and up to six additional slides. The additional slides may include embedded audio (MP3, WMA) or video (AVI, M4V, MP4, MOV, WEBM).

A submitted slideshow must be entirely self-contained – it must not include links to content outside of the submission (e.g. a link that takes the assessor to a YouTube video or a file in Google Drive). Any such linked content will not be considered for assessment.

If the school does not have the required technology to embed audio or video files into a slideshow, the candidate may submit the slideshow and audio / video files separately.

The maximum (combined) file size that may be submitted is 5GB.

Additional slides (up to 6)

The body of the report may contain written evidence and / or embedded audio and video evidence.

- For written evidence, the candidate is encouraged to write a concise response of no more than 1,200 words.
- For audio or video evidence, the candidate should include no more than 4 minutes of evidence in total. Audio and video evidence may include a mix of direct candidate voice, interview, recorded physical drama work accompanied by explanation, or other audio techniques.

Conditions of assessment

Candidates are recommended to spend no more than 4–6 hours of class time to individually research and produce their report under teacher supervision.

The drama performance must be an appropriate drama for Level 6 of the curriculum to ensure candidates have the opportunity to respond at every level of achievement for this standard.
