- the effect of social, cultural, geographical, political, artistic, and technological influences on the dance genre
 - the contribution of individuals and/or groups
 - the relationship between dance and the context in which it is practised
 - the way that dance genres and/or styles have changed or been maintained.

 - settings
 - significant performances and events
