Analyse, in depth, a food related ethical dilemma for New Zealand society involves:

- exploring the underlying beliefs, values, and practices associated with those holding contrasting viewpoints
- explaining how the underlying beliefs, values, and practices influence viewpoints relating to the ethical dilemma.

Analyse comprehensively a food related ethical dilemma for New Zealand society involves:

- critically evaluating the viewpoints of different stakeholders and outlining some possible consequences and challenges for New Zealand society.
- 3 *A food related ethical dilemma* is one that challenges beliefs, values, and practices related to food. An ethical dilemma requires a choice to be made between two or more options. All options may be equally desirable, or they may all be morally acceptable but mutually exclusive.
- 4 A food related ethical dilemma may relate to:
 - fortified foods
 - intensive food production
 - sponsorship
 - country of origin labelling
 - genetic modification
 - unsustainable practices
 - fluoridation of water
 - fair trade
 - taxation of food
 - marketing of energy dense, nutrient poor food directed at children
 - food sovereignty.
