- 2 *Conduct* involves:
 - developing a statement of the aim and purpose linked to a psychological concept or idea
 - selecting an appropriate research method
 - developing the procedure
 - considering and complying with the New Zealand Code of Ethics
 - selecting and recording data
 - reaching a valid conclusion derived from the findings which is relevant to the purpose of the investigation
 - interpreting and reporting on the findings.

Conduct, in depth, involves:

- effective research design
- describing the reasons for the choice of the method used to conduct psychological research
- evaluating the appropriateness of the method design and/or the validity and reliability of the data making reference to resources. For example, the New Zealand Code of Ethics and statistical analysis
- discussing the psychological ideas relating to the research based on the findings.

Comprehensively conduct involves:

- justifying the research design and method used
- using the findings to inform future research direction or next steps that might be taken
- providing a list of sources.
- 3 *With consultation* involves the teacher providing feedback. For example:
 - appropriateness of the psychological research
 - progress discussions
 - ensuring the proposed research is ethical
 - providing broad experimental conditions such as the availability of equipment or participants.
- 4 *Psychological research* refers to research carried out in the context of studying human or non-human animal behaviour.
- 5 *Independent* involves students designing and conducting their own psychological research.
