### Purpose

### Previous versions of the qualification

Version 5 was reviewed and issued in February 2008.

Changes to structure and content: Amended to show Community Support Services Industry Training Organisation responsibility; Standard 129 was deleted as it had expired and was not being replaced; Classification of standards 7393-7395 was updated to reflect new domain Guide Dog Training; Credit total decreased from 286 to 283; Title changed to reflect the classification name.

Version 4 was issued to extend the registration period, change the standards setting body from Animal Nursing and Technology (ANTECH) Board to NZQA, and update the identification number for the recommended Massey University qualification.

Version 3 was to extend the period of registration.

Version 2 was issued to take account of the Business Administration unit standard review.
