Those currently enrolled in programmes leading to the replaced qualification may complete this or transfer to the replacement New Zealand qualification.

The last date for entry for the replaced qualification is 30 June 2018. Providers need to ensure any candidates enrolled in programmes after the listing of the New Zealand qualification will have sufficient time to complete by the last date for assessment.

Existing candidates may either complete programmes leading to the replaced qualification or transfer results to the New Zealand qualification. The last date to meet the requirements of the replaced qualification is 31 December 2018. At that point the qualification will be designated discontinued and from that date no results can be reported against the qualification.

It is anticipated that no existing candidates will be disadvantaged by these transition arrangements. However, anyone who feels that they have been disadvantaged may appeal to NQS at the address below. Appeals will be considered on a case-by-case basis.

Purpose

The National Certificate in Adult Education and Training (Level 4) with strands in New Zealand Environment, and International Environment is designed for people delivering and assessing in adult education and training environments. The qualification has been designed for people who are seeking a general entry-level qualification in the adult education and training field either within New Zealand or internationally.

The qualification has the flexibility to accommodate different personal, work, and skill requirements from across the National Qualifications Framework.

People awarded the New Zealand Environment strand of this qualification are able to identify the diverse cultural and educational needs of adult learners and establish an inclusive learning environment for adult learners within New Zealand, with particular focus on the Māori and Pakeha cultures of New Zealand.

People awarded the International Environment strand of this qualification are able to teach and train adult learners in learning environments outside New Zealand and are able to establish inclusive multicultural learning environments for these learners.

Core Elective 1 reflects competency in the delivery of adult education and training and open, flexible, and networked learning. Core Elective 2 allows people to gain credit in areas such as delivery of adult education and training; adult literacy and numeracy education; design and development of adult education and training; evaluation in adult education and training; assessment of learning; open, flexible, and networked learning, and Te mātauranga Māori whāiti (Adult Māori Education and Training). Core Elective 3 allows people to gain credit from anywhere on the National Qualifications Framework.

There are no prerequisites to entry. This qualification may stand alone or lead on to the National Certificate in Adult Education and Training (Level 5) with strands in New Zealand Environment, and International Environment [Ref: 0379] and/or the National Diploma in Adult Education and Training (Level 6) [Ref: 1549].

Special Notes

People may be granted recognition of current competence (RCC) on application to an accredited provider. Candidates for RCC must go through an assessment process carried out by registered assessors in accordance with NZQA guidelines.

Version 5 was issued following review.

Changes to structure and content

- qualification was stranded to allow for application in New Zealand and International environments and the compulsory section was removed
- Electives 1 and 2 were replaced by Core Electives 1 and 2 respectively; the balance set from Elective 2 was included as Core Elective 3
- standard 7091 (from the compulsory section) was included in the New Zealand Environment strand and new standard 26009 was added to form the International Environment strand
- credit requirements for Core Elective 1 and Core Elective 2 were reduced from 16 to 8 and from 20 to 18 respectively
- the Assessment of Learning domain from Elective 1 was included in Core Elective 2
- the Adult Literacy and Numeracy Education; Delivery of Adult Education and Training; Design and Development of Adult Education and Training; Evaluation in Adult Education and Training; and Open, Flexible and Networked Learning domains were specified in Core Elective 2, replacing the Adult Education and Training subfield from Elective 2
- the Te Mātauranga Māori Whāiti domain was added to Core Elective 2
- the Open and Distance Learning domain was replaced by the Open, Flexible, and Networked Learning Domain in Core Elective 1.

Version 4 was issued following review. Changes to structure and content included: Elective 1 requirements were reduced from 20 to 16 credits; credit total for the qualification was consequently reduced from 44 to 40 credits; and the domain Open and Distance Learning was added to elective 1.

Version 3 was issued in order to amend the rules and allow all credits to be drawn from the Adult Education and Training subfield in elective 2.

Version 2 was issued in order to amend the rules and allow 10 credits from anywhere on the National Qualifications Framework.
