Purpose

This qualification is designed for people working in urban fire and rescue services in the structural and industrial fire fighting environment, towards achievement of the position of Qualified Firefighter. This is the second of three progressive qualifications developed for urban fire and rescue firefighters.

The skilled usage, and specialist emergency application, of equipment such as breathing apparatus and portable pumps makes this qualification more specialised than the National Certificate in Fire and Rescue Services (Urban Fire and Rescue Operations) (Level 2) [Ref: 0537], which is a prerequisite.

Competency in the knowledge and skill required for the award of this qualification provides a thorough grounding in the fire and rescue services industry.

The compulsory section contains standards covering fire safety and control, knowledge of fires, fire fighting equipment, and operations related to structural and industrial fires, as well as the Coordinated Incident Management System (CIMS) and first aid for trauma and medical emergency situations.

The elective section allows for broad options from within the Fire and Rescue Services domains, and allows a choice of standards from the National Qualifications Framework. This is designed to allow the inclusion of fire and rescue, communications, community support, or other standards that are relevant to the industry.

Transition Arrangements**Version 4**

Version 4 was issued following the review of standards in the Community and Workplace Fire and Emergency Management subfield.

Changes to structure and content

- standard 17279 has decreased from 4 to 2 credits
- standard 23406 has been added to the Compulsory section
- standards 6400 and 6401 have been removed
- provision for allowing credit for standards 3282 and 3306 as an exemption for 20392 has been removed, along with the Fire and Rescue Services – Airport, and Urban Search and Rescue – Operations domains, which are not included in the qualification requirements.

Previous versions of the qualification

Version 3 was issued following a review of standards in the Fire and Rescue Services subfield. The title of the qualification was changed and the credit value reduced.

Version 2 was issued to take account of standard reviews. The Community and Workplace Fire and Emergency Management subfield was added to the Elective section, reclassified standards were updated, and standard 6401 was added to the Compulsory section. Transition arrangements were included for people with credit for Fire Fighting standards.

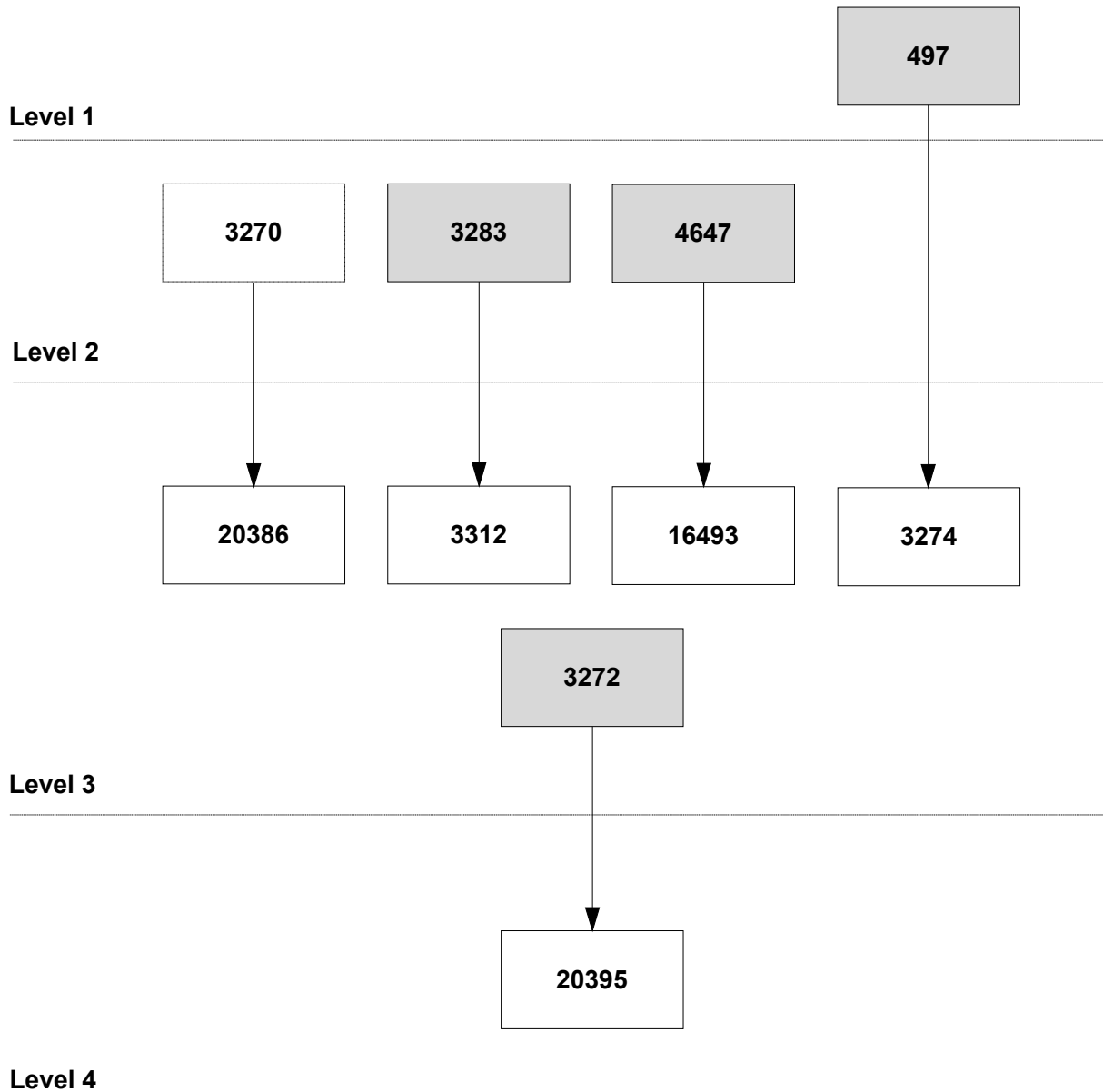
