

National Certificate in Māori Performing Arts (Performance) (Level 4)

Purpose

The National Certificate in Māori Performing Arts (Performance) (Level 4) [Ref: 0701] recognises the skills of an experienced performer in the area of Māori performing arts. The holder of the qualification is able to demonstrate the skills and knowledge of the disciplines of the Māori performing arts.

Three elective sections from Field Māori are included to recognise the range of skills held in high regard by the Māori Performing Arts community, to enable people to specialise in an area of Māori performance, as well as providing scope for the extension of knowledge and skills in the Māori performing arts.

The National Diploma in Māori Performing Arts (Tutoring) (Level 6) [Ref: 1088] provides a pathway for people to further the skills recognised in this qualification.

Special Notes

The level 3 and 4 *Māori Performance* standards in this qualification require the attainment of credits for *Reo Māori* standards at levels 1 and 2 in the *kōrero*, *whakarongo*, *tuhituhi* and *pānui* domains. The pathways are shown in the relationships diagram later in this document.

While prerequisite standards are not specified in this qualification, candidates may choose level 2 *Reo Māori* standards to meet the requirements of Elective C. Candidates may also have gained credit for level 1 and 2 *Reo Māori* standards through the National Certificate in Māori (Te Waharoa) (Level 2) [Ref: 0878] or the National Certificate in Reo Māori (Level 4) [Ref: 0426].

This qualification will be awarded to people who meet the requirements of the compulsory and elective sections.

Award of NQF Qualifications

Transition Arrangements**Version 3**

Version 3 was issued following review. New standards at Level 3 in the Field Māori domain of Māori Performance on the National Qualifications Framework have been included.

Changes to structure and content

- The total credit value of the qualification has increased from 80 to 120 credits.
- Standards 22756 and 22757 have been added to the compulsory section – resulting in an increase of credits from 42 to 58.
- The rule for Elective C has been adjusted to require a 'balance of credits' to meet the overall requirement for 120 credits.

People currently working towards version 2 of this qualification may either complete the requirements for that version or transfer their results to this version of the qualification.

It is not intended that anyone is disadvantaged by this review, and the above arrangements have been designed for a smooth transition. However, anyone who feels they have been disadvantaged may appeal to Māori Qualifications Services at the address below.

Previous versions of the qualification

Version 2 was issued following review. The requirements were restructured and new Field Māori domains on the National Qualifications Framework were included. Changes to structure and content included: purpose statement amended to include reference to the Diploma in Māori Performing Arts (Tutoring) (Level 6) [Ref: 1088] as a pathway; standards 15019 and 15020 moved from the compulsory section to Elective A; elective standards 13359 and 13360 moved to the compulsory section; credit total for the compulsory section increased from 30 to 42 credits; credit requirement for Elective A increased from 6 to 9 credits; and credit requirement for Elective B reduced from 30 to 15 credits to maintain the total credit value of the qualification at 80 credits. The Dance, Drama, Music and Performing Arts General, Ngā Mahi a te Rēhia subfields were removed from Elective C; Māori Performing Arts domains developed since the registration of the qualification and the General Education Māori subfield were added to Elective C; the Prerequisite Diagram was reformatted to show all of the Reo Māori standards required to complete the qualification; and a special note was added to explain the prerequisite pathway. The level of the qualification was added to the title. Transition enabled people working towards version 1 of this qualification may either complete its requirements or transfer to version 2.
