Purpose

This is an introductory qualification for people who are beginners in weaving, or who have an interest in the knowledge and skills in Ngā Mahi ā te Whare Pora.

The compulsory section recognises foundation skills and knowledge in the Raranga, Tāniko, Taonga Tākaro, and Whatu domains.

The elective section in the qualification is flexible and allows for the selection of standards from anywhere in field Māori, to broaden the learners' skills and knowledge in te ao Māori.

Credits gained from this qualification may also contribute towards the award of the National Certificate in Māori (Te Waharoa) (Level 2) [Ref: 0878], the National Certificate in Educational Achievement (NCEA) (Level 2) [Ref: 0973], and the National Certificate in Educational Achievement (NCEA) (Level 3) [Ref: 1039].

This qualification also offers pathways to the National Certificate in Māori Business Management (Level 4) [Ref: 0365], and the National Certificate in Māori (Te Ngutu Awa) (Level 4) [Ref: 1006].

Tikanga pertinent to the mana whenua is interwoven through all practices of Ngā Mahi ā te Whare Pora.
