Purpose

The National Certificate in Commercial Road Transport (Logging Truck Driver) [Ref: 0942] recognises that the holder has the knowledge and skills for the safe, lawful, and efficient performance of the role of a heavy combination vehicle driver transporting logs by road.

The holder will be able to drive competently in the range of required road environments and conditions, select and record routes, demonstrate safe work practice and knowledge of forestry, log loading, and log transport requirements and procedures, and demonstrate and apply knowledge of heavy combination vehicles and their handling.

In addition, the holder will have demonstrated a range of knowledge and skills that are both relevant to the role of logging truck driver and reflect individual and/or organisational needs.

Where necessary, the holder will have met the statutory and or regulatory requirements specified in the unit standards required.

This certificate reflects the unique needs of the industry sector and, for specialist logging truck drivers, provides an alternative and more streamlined qualification pathway than that offered by selecting the Heavy Combination Vehicle Driver Strand and the Log Transport Optional Strand as part of the *National Certificate in Commercial Road Transport (Goods Service)* [Ref: 0680]. The stranded qualification with the log transport strand option is more suited to drivers who undertake or intend to undertake log transport, but who also have more general commercial road transport career intentions, especially in regard to driving heavy combination vehicles.


