

National Diploma in Te Mātauranga Māori me te Whakangungu (Level 5)

Purpose

This qualification is designed for graduates following a career that requires working with adult Māori learners. Holders of the qualification are able to deliver, design and develop, assess and evaluate adult education and training that is meaningful for Māori learners.

People awarded this qualification are able to design, plan and implement educational programmes for Māori in adult education and training, have knowledge of Māori learning, and are able to communicate effectively with their target audience. They also have an understanding of Te Tiriti o Waitangi and its implications within an education context, and of mātauranga Māori research methods, ethics, and methodologies.

The elective section of this qualification has two options, and is structured to provide a sound basis for pursuing further academic study in education or developing Māori knowledge and skills. Option A allows people to choose standards from various subfields in Field Māori or Education, which best suit the type of Adult Education and Training in which they are involved. Option B has credits in common with the prerequisite qualification. It is designed to develop knowledge of Māori human development theory in terms of Māori concepts, values and practices, and extend this to include areas of Māori human development theory for adolescents, adults, or kaumātua. This option also allows people the opportunity to select the most appropriate knowledge and skills from anywhere on the National Qualifications Framework to best suit the type of Adult Education and Training in which they are involved.

This qualification can include or build on the National Certificate in Te Mātauranga Māori me te Whakangungu (Māori Human Development Theory) (Level 4) [Ref: 1139] depending on the standards selected for that qualification. The compulsory section of this qualification also shares standards with the National Certificate in Te Mātauranga Māori me te Whakangungu (Te Tiriti o Waitangi in Education) (Level 5) [Ref: 1140]. Depending on the choices made in the elective section, some standards from this qualification may also be used toward the National Diploma in Adult Education and Training (Level 5) [Ref: 0380].

Prerequisite: National Certificate in Te Mātauranga Māori me te Whakangungu (Māori Human Development Theory) (Level 4) [Ref: 1139], or demonstrate equivalent knowledge and skills.

Transition Arrangements**Version 2**

Version 2 of this qualification was issued following a review to ensure it was fit for purpose and met industry requirements.

Changes to structure and content

- Titles of standards 3693, 3697, 3698, 18588, and 18590 have been updated to take into account the changes made at review.
- Standard 16164 and expiring standard 18587 are no longer listed in the Compulsory section but can be used the requirements for Option A or Set 3 of Option B in the elective.
- Standard 3706 has been added to the Compulsory section of the qualification.

- Credits for standard 3693 decreased from 5 to 4 credits.
- The Elective section has been amended and allows a choice between Option A and Option B.
- Expiring domain Open and Distance Learning has been replaced with Open, Flexible, and Networked Learning in Option A.
- The Te Mātauranga Māori me te Whakangungu subfield has been added to Option A.
- Total credits for the qualification decreased from 121 to 120 credits.
