

National Certificate in Floor and Wall Tiling (Introductory Skills) (Level 2)

This qualification is **expiring**. The last date to meet the requirements is 31 December 2013.

Purpose

This national certificate is designed as an entry level qualification that recognises the skills and knowledge of an introductory floor and wall tiling worker. It also provides a means of recognising current competence for those already working in the industry.

The holder of this qualification is able to describe the use of primers and adhesives, grouts and grout additives, and sealants for floor and wall tiling, and demonstrate knowledge of work area set-up, surface preparation, floor and wall tile installation, and under tile heating systems and their installation for floor and wall tiling. They will be able to use hand tools and power tools, and under supervision set up work areas, perform surface preparation and install tiles.

This qualification has a significant health and safety component in recognition of the nature of the construction environment, and holders of the qualification are able to manage first aid, provide first aid and provide resuscitation. They are also able to demonstrate knowledge of and carry out health and safety procedures for a building construction site.

This qualification provides underpinning knowledge and skills important to the performance of individuals at all stages in the Floor and Wall Tiling industry. It is recommended that people following a career in the Floor and Wall Tiling industry start with this qualification. This qualification also provides people with the necessary skills and knowledge for entry into the National Certificate in Floor and Wall Tiling [Ref: 0726].

Special Notes

Due to the health and safety requirements of the sites in which these trade skills are applied, people entering programmes of education and training leading to the award of this qualification must demonstrate the capacity to understand any and all requirements, instructions, and communications (oral, written and graphic), to the required industry level. This might be evidenced by Sixth Form Certificate or NCEA level 2 English, credits from the *Communication Skills* sub-field at level 2 or above, or the demonstration of equivalent knowledge and skills.

Assessment of recognition for current competence may be conducted by an assessor appointed by the Building and Construction Industry Training Organisation, or an accredited provider.

Application for recognition of current competence supported by appropriate documentation may be directed to the Manager – Operations, Building and Construction Industry Training Organisation.
