Purpose

The National Diploma in Community Recreation (Facility Management) (Level 5) is a qualification that recognises the skills and knowledge required for management of recreation facilities and associated resources, programmes and services.

People awarded this qualification are able to fulfil the role of facility manager in planning for, implementing and evaluating all aspects of a recreation facility, its development and operation.

This qualification provides opportunity for team leaders, supervisors and managers within a community recreation facility to develop specific community recreation facility skills underpinned by generic management competencies.

This qualification builds on the National Certificate in Community Recreation (Programme and Event Management) (Level 4) [Ref: 0939] and the National Certificate in Community Recreation (Aquatics) (Level 4) [Ref: 0938] and can lead on to the National Diploma in Community Recreation (Programme and Event Management) (Level 6) [Ref: 0941].
