Purpose

This qualification is for people who may have a background in the agriculture industry, and who wish to develop skills and knowledge in the Tb testing of domestic cattle and deer.

People credited with this qualification are able to prepare themselves and equipment, and assess facilities for Tb testing; carry out and read caudal fold intradermal Tb tests for cattle; prepare for, carry out, and read comparative cervical tests (CCTs), and mid cervical tests (MCTs) for deer; bleed cattle and deer for Tb testing, complete documentation and submit samples to the testing laboratory; and prepare Tb reactor valuation contracts for dairy and beef cattle.

These people will have knowledge of the National Bovine Tuberculosis Pest Management Strategy and animal identification schemes; Tb infection transmission and control; and classification of cattle and deer for Tb testing.

All standards in the qualification are compulsory because the Tb testing process requires a set of well-defined skills and knowledge that applies across all workplaces.

This qualification builds on the skills and knowledge in the National Certificate in Agriculture (Animal Health and Husbandry) (Level 3) with the Cattle Farming Strand [Ref: 1438], the National Certificate in Agriculture (Cattle Breeding) (Level 3) with strands in Beef Cattle Farming, and Dairy Cattle Farming [Ref: 1436], and the National Certificate in Deer Farming (Level 3) [Ref: 1442].

On completion of the qualification people may progress to other agriculture industry qualifications such as the National Certificate in Agriculture (Level 4) with the Cattle Farming Strand or Deer Farming Strand [Ref: 0986].

Replacement Information

This qualification has been replaced by the National Certificate in Tuberculosis (Tb) Testing of Domestic Cattle and Deer (Domestic Cattle) with an optional strand in Deer [Ref: 1611].

Special Notes

Successful completion of this qualification does not qualify a person to operate as a Tb tester under the Biosecurity Act 1993 and Biosecurity (National Bovine Tuberculosis Pest Management Strategy) Order 1998.

The Animal Health Board is responsible for the implementation of an additional set of processes and requirements under the Biosecurity Act 1993 and Biosecurity (National Bovine Tuberculosis Pest Management Strategy) Order 1998, to have people accredited to test domestic cattle and deer for Tb.
