### **Purpose**

The National Certificate in Reo Māori Media (Foundation Media Skills) (Level 4) [Ref: 1630] is designed to raise the quality of te reo Māori within the media industry and recognise the core reo Māori media skills and knowledge required to work in the Māori radio, television, and print industries. It is aimed primarily at people who want to pursue a career in these industries, or people who have recently started working in the industries.

The qualification includes compulsory standards which cover skills and knowledge essential for the Reo Māori Media context.

This qualification leads to, and is a prerequisite for the award of, the National Diploma in Reo Māori Media (Level 5) with strands in Radio, and Journalism [Ref: 1146].

It is intended that training, delivery, and assessment for this qualification is conducted predominantly in te reo Māori.

## **Special Notes**

It is recommended that candidates have previously achieved credit for Level 2 standards in both the *Kōrero* and *Whakarongo* domains; or possess equivalent skills and knowledge.

It is also recommended that candidates possess basic word processing skills and are aware of the principles of Occupational Safety and Health.

It is also recommended that candidates possess basic level word processing skills and knowledge of Occupational Safety and Health principles.

People who already possess skills and knowledge relevant to this qualification are encouraged to seek recognition through the provider's Recognition of Current Competence (RCC) process.
