### **Ngā kaupapa o te tohu / Guiding Principles**

This qualification is underpinned by the following principles:

#### ***Horopaki Toi***

This principle encompasses a range of contexts that inform current view, and potential future direction(s), of Ngā Toi; as well as how they can influence other activities not generally considered art.

This principle also relates to *pūkengatanga* and *kaitiakitanga*, as expressed in Te Hono o Te Kahurangi.

#### ***Hātepe Auaha***

This principle describes the means by which a practitioner formulates an original idea and then manifests that idea into reality. It involves the sequential formation and creative process.

This principle also relates to *pūkengatanga*, as expressed in Te Hono o Te Kahurangi.

#### ***Mahi Toi***

This principle signifies the fundamental study of Ngā Toi in a chosen medium and a rationalisation for the project.

This principle also relates to *kaitiakitanga*, as expressed in Te Hono o Te Kahurangi.

#### ***Rangatiratanga***

This principle describes the skills and knowledge required to effectively plan, propose, execute, and report on a successful Ngā Toi project, as well as the processes, kawa and tikanga that are utilised for its protection and management.

This principle also relates to *rangatiratanga*, as expressed in Te Hono o Te Kahurangi.

### **Ngā huarahi mātauranga / Education Pathway**

The qualification provides a pathway for those seeking to improve or further develop their skills and knowledge in Ngā Toi.

Graduates may progress to the New Zealand Certificate in Ngā Toi (Level 4) [Ref: 2790].

### **Ko ngā huarahi ā-mahi, ā-ahurea, ā-whānau, ā-hapū, ā-iwi, ā-hapori anō hoki / Employment, Cultural, Community Pathways.**

Graduates of this qualification will have the skills and knowledge to contribute to Ngā Toi projects, under broad supervision, with whānau, hapū, iwi, and hapori; and to provide support in terms of their Ngā Toi development and aspirations.

Graduates will have skills and knowledge to work in, or contribute to Ngā Toi practice, and the sector.

Graduates may provide Ngā Toi in a range of contexts for whānau, hapū, iwi, and hapori projects.

Programmes can include a single project brief or a selection of project briefs. They may focus on one Toi or a selection of Toi that compliment Toi ora in the delivery context.

Programmes leading to this qualification will be underpinned by the guiding principles as set out in the qualification details, above. This may include threading te reo Māori and tikanga Māori learning throughout programmes and should include aspects of each of the following:

- Horopaki Toi – the study of context, which may involve history, theory and current thinking, culminating in knowing that informs the practitioner’s practice. These include activities that support the transfer of ideas from one discipline to another.
- Hātepe Auaha – the transformation of raw material into the final piece and itemising each step of a coherent process. This allows the practitioner to retrospectively analyse the success or failure of any part of the creative process.
- Mahi Toi – the technical skill of the practitioner in manipulating the medium, including their ability to successfully solve problems to complete project in accordance with its brief, and analyse the advantages and disadvantages of the choice of medium. It is the knowledge and skill of the practitioner in terms of medium (or media) manipulation.
- Rangatiratanga – project management skills (workload and timeline identification, priority allocation, working to plan (including planning for contingencies), and resolving issues), which enable practitioners to deliver a product to a particular standard of quality, at a particular time. It is the skills and knowledge in this kaupapa which helps transform a hobbyist into a commissioned/ professional/ recognised practitioner.
