Performance criteria

1.1 Acts of importance to the work of electricians are identified.

1.2 Regulations of importance to the work of electricians are identified.

Range Building Act 2004, Electricity (Safety) Regulations 2010.

1.3 Key standards of importance to the work of electricians are identified.

Range AS/NZS 3000, AS/NZS 3760.

1.4 Organisations that impact on the work of electricians are identified.

Range Electrical Worker's Registration Board (EWRB), Ministry of Business, Innovation and Employment, electrical supply companies (energy suppliers), electrical industry associations.

1.5 The purpose of site safety identifications, such as the Site Safe Passport, is explained.

Outcome 2

Demonstrate knowledge of the responsibilities and limitations of registered electricians.

Performance criteria

- 2.1 Supervision requirements for trainees and electrical workers not allowed to take responsibility are described in accordance with the *Supervision Companion Guide* and associated EWRB policies.
- 2.2 Requirements necessary for a person to be registered, licensed, or authorised are explained in accordance with the current regulations and Standards.
- 2.3 The limits and restrictions that the EWRB may impose upon registered persons are described in terms of the type of work that may be undertaken, and where and for whom the registered person may work.

2.4 Prescribed electrical work that electricians may do is defined in accordance with the current regulations.

2.5 The responsibilities of persons carrying out prescribed electrical work are stated in accordance with current regulations.

Range

responsibilities – compliance with the current regulations and standards as they apply to the work undertaken, high standard of workmanship, safe working practices, certification of prescribed electrical work.

- 2.6 Persons who may assist a registered electrician in carrying out prescribed electrical work are identified in accordance with current regulations and Standards.
- 2.7 Requirement that prescribed electrical work is subject to audit by the EWRB is stated in accordance with current regulations and Standards.
- 2.8 Electrical work requiring inspection, and persons qualified to inspect are identified in accordance with current regulations and Standards.
- 2.9 Competency requirements and safety tuition for electricians are explained in accordance with the Electricity (Safety) Regulations.

Outcome 3

Demonstrate knowledge of the Electricity (Safety) Regulations.

Performance criteria

- 3.1 The structure of the Electricity (Safety) Regulations is described in terms of the relationship between it, the Act, other regulations, Codes of Practice, and Standards.
- 3.2 Passages for given subjects are located in the Electricity (Safety) Regulations.

Range location of five unrelated regulations.

Outcome 4

Demonstrate knowledge of AS/NZS 3000.

Performance criteria

- 4.1 The structure of AS/NZS 3000 is described in terms of clauses that are mandatory and those which are only a means of compliance.
- 4.2 The fundamental safety outcomes contained in AS/NZS 3000 are stated in terms of protection of people and property.
- 4.3 Testing and verification of electrical work is explained in terms of AS/NZS 3000.
