## Guidance Information

- 1 Assessment information  
This unit standard must be assessed against on-job.  
All activities and performance criteria must be carried out in accordance with worksite policies and procedures.
- 2 Personal protective equipment, appropriate to job requirements, must be selected and used in accordance with worksite policies and procedures and manufacturer's instructions.
- 3 Definitions  
*Manufacturer's instructions* are instructions provided by manufacturers of substances, equipment, and machinery used in furniture making. These instructions may include details on safe and correct handling, use and storage of substances and/or details on substance properties. Examples are labels on substance containers, product data sheets, and operator's manuals.  
*SOIs* refer to safe operating instructions which are documented instructions attached to machines which detail requirements for safe operation of the particular machine.  
*Worksite policies and procedures* refer to documented policies and to documented or other directions provided to staff. These may include, but are not limited to, ways of managing health and safety, environmental considerations, quality, and production, and must conform to legislation. Examples include standard operating procedures, company health and safety plans, on-site briefings, and supervisor's instructions.

## Outcomes and performance criteria

### Outcome 1

Demonstrate and apply knowledge of preparing to set a four sider to square dress wooden furniture components.

**Performance criteria**

- 1.1 Job specifications are obtained and interpreted.
- Range material, component dimensions, number of components, timeframe.
- 1.2 Method for setting the machine is explained in accordance with manufacturer's instructions.
- Range bottom cutter head, side cutter heads, top cutter head, feed rollers.
- 1.3 Method for adjusting the machine is explained in accordance with manufacturer's instructions.
- Range width, thickness, feed speed.
- 1.4 Tooling and material are selected in accordance with job specifications.
- 1.5 Environmental and safety requirements are met.
- Range electrical power, lighting, ventilation, dust extraction.

**Outcome 2**

Set a four sider to square dress wooden furniture components.

**Performance criteria**

- 2.1 Machine is isolated from the power sources during set-up.
- 2.2 Straight knives are removed and replaced in the cutter head in accordance with manufacturer's instructions and job specifications.
- Range equal projection, secure.
- 2.3 Cutter heads are secured onto the spindles in accordance with manufacturer's instructions and job specifications.
- 2.4 Machine is set in accordance with job specifications, manufacturer's instructions, and SOIs.
- Range feed rollers, feed speed, width, thickness, fences, safety guards.
- 2.5 Test piece is run and checked against job specifications. Any required adjustments to machine settings are made.
- Range width of test piece, thickness of test piece, pitch of cutter marks.
- 2.6 Work area is made clean, clear, and safe.
