 - All activities and performance criteria must be carried out in accordance with worksite policies and procedures.
- 2 Personal protective equipment, appropriate to job requirements, must be selected and used in accordance with manufacturer's instructions.
- 3 Definitions
 - Manufacturer's instructions are instructions provided by manufacturers of substances, equipment, and machinery used in furniture making. These instructions may include details on safe and correct handling, use and storage of substances and/or details on substance properties. Examples are labels on substance containers, product data sheets, and operator's manuals.
 - *SOIs* refer to safe operating instructions which are documented instructions attached to machines which detail requirements for safe operation of the particular machine. *Worksite policies and procedures* refer to documented policies and to documented or other directions provided to staff. These may include, but are not limited to, ways of managing health and safety, environmental considerations, quality, and production, and must conform to legislation. Examples include standard operating procedures, company health and safety plans, on-site briefings, and supervisor's instructions.

Outcome 1

Demonstrate and apply knowledge of preparing to set a four sider to produce moulded profile wooden furniture components.

1.1 Job specifications are obtained and interpreted.

Range material, component dimensions and profile, number of components, timeframe.

1.2 Method for setting the machine is explained in accordance with manufacturer's instructions.

Range bottom cutter head, side cutter heads, top cutter head, feed rollers.

1.3 Method for adjusting the machine is explained in accordance with manufacturer's instructions.

Range width, thickness, feed speed.

- 1.4 Tooling and material are selected in accordance with job specifications.
- 1.5 Environmental and safety requirements are met.

Range electrical power, lighting, ventilation, dust extraction.

Outcome 2

Set a four sider to produce moulded profile wooden furniture components.

Performance criteria

- 2.1 Machine is isolated from the power sources during set-up.
- 2.2 Top cutter head knives are changed in accordance with manufacturer's instructions and job specifications.

Range correct profile, correct projection.

2.3 Bottom cutter head knives are changed and set in accordance with job specifications.

Range correct profile, correct projection.

2.4 Both side cutter heads are changed and set in accordance with job specifications.

Range correct profile, correct projection.

2.5 Cutter heads are secured on spindles of the machine in accordance with manufacturer's instructions.

2.6 Machine is set in accordance with job specifications, manufacturer's instructions, and SOIs.

Range feed rollers, feed speed, pressure pads, width, thickness, fences, safety guards.

2.7 Test piece is run and checked against job specifications. Any required adjustments to machine settings are made in accordance with job specifications.

Range width of test piece, thickness of test piece, profile of test piece.

- 2.8 Job specifications are explained to the operator.
- 2.9 Work area is made clean, clear, and safe.
