- 2.1 A full-size component drawing is set out in accordance with job specifications.
- 2.2 Template is produced and marked onto the material.
- 2.3 Material for former is machined and assembled in accordance with job specifications.
- 2.4 Test component is laminated and checked.
- 2.5 Former is labelled and stored safely and securely.
- 2.6 Work area is left clean, clear, and safe.
