### Guidance Information

- 1 Assessment information  
This unit standard may be assessed against on-job or off-job.  
All activities and performance criteria must be carried out in accordance with worksite policies and procedures.
- 2 Range  
Demonstration of competence must include the fitting of at least two of – glass accessory, mirror, plastic accessory, metal accessory, perspex accessory.
- 3 Personal protective equipment, appropriate to job requirements, must be selected and used in accordance with worksite policies and procedures and manufacturer's instructions.
- 4 Definitions  
*Manufacturer's instructions* are instructions provided by manufacturers of substances, equipment, and machinery used in furniture making. These instructions may include details on safe and correct handling, use and storage of substances and/or details on substance properties. Examples are labels on substance containers, product data sheets, and operator's manuals.  
*Worksite policies and procedures* refer to documented policies and to documented or other directions provided to staff. These may include, but are not limited to, ways of managing health and safety, environmental considerations, quality, and production, and must conform to legislation. Examples include standard operating procedures, company health and safety plans, on-site briefings, and supervisor's instructions.

### Outcomes and performance criteria

#### Outcome 1

Demonstrate and apply knowledge of preparing to attach accessories to furniture.

**Performance criteria**

- 1.1 Job specifications are obtained and interpreted.  
Range type of accessory.
- 1.2 Accessories are selected in accordance with job specifications.
- 1.3 Methods of attachment for accessories are explained in accordance with job specifications.
- 1.4 Tools and equipment are selected in accordance with job specifications.

**Outcome 2**

Demonstrate and apply knowledge of attaching accessories to furniture.

**Performance criteria**

- 2.1 Methods of protecting accessories and furniture articles during fitting are explained.
- 2.2 Accessories to be fitted to furniture article are checked for defects and action to be taken if defects are found is explained.
- 2.3 Accessories are positioned and attached in accordance with job specifications.
- 2.4 Accessories are handled in accordance manufacturer's instructions.
- 2.5 Tools and equipment are used in accordance with manufacturer's instructions.
- 2.6 Accessories are fitted to meet job specifications.  
Range firm fit, square, true, free from excess glue.
- 2.7 Work areas are made clean, clear, and safe.
