Guidance Information

1 Assessment information

This unit standard must be assessed against on-job.

All activities and performance criteria must be carried out in accordance with worksite policies and procedures.

- Personal protective equipment (PPE), appropriate to job requirements, must be selected and used in accordance with worksite policies and procedures and manufacturer's instructions. For this unit standard PPE includes but is not limited to gloves, eye protection, respiratory protection, clothing protection, footwear.
- 3 Definitions

Antique refers to an object of more than 100 years old, valued for its aesthetic or historical significance.

Manufacturer's instructions are instructions provided by manufacturers of substances, equipment, and machinery used in furniture making. These instructions may include details on safe and correct handling, use and storage of substances and/or details on substance properties. Examples are labels on substance containers, product data sheets, and operator's manuals.

MSDS refers to Material Safety Data Sheets which are documents containing information on toxic substances used in the worksite. It is a requirement of the Environmental Risk Management Authority that all worksites using toxic substances have an MSDS.

Worksite policies and procedures refer to documented policies and to documented or other directions provided to staff. These may include, but are not limited to, ways of managing health and safety, environmental considerations, quality, and production, and must conform to legislation. Examples include standard operating procedures, company health and safety plans, on-site briefings, and supervisor's instructions.

Outcomes and performance criteria

Outcome 1

Prepare to repair antique wooden furniture.

Performance criteria

1.1 Furniture article is examined to determine its characteristics in accordance with job specifications.

Range extent of repairs, age, history of furniture article, physical features.

1.2 Job specifications are obtained and interpreted.

Range replacement materials, methods of structural restoration, methods of surface restoration, type and methods of finish.

- 1.3 Tools and equipment are selected in accordance with job specifications.
- 1.4 Materials for the job are selected in accordance with job specifications.

Range any of – solid wood, veneer, solvents, adhesives, abrasives, filling compounds.

1.5 Work area is selected.

Range ventilation, lighting.

Outcome 2

Prepare antique wooden furniture for repair.

Performance criteria

- 2.1 Surface of the furniture is stripped of finish in accordance with job specifications.
- 2.2 Surface of the furniture is washed and cleaned up after stripping in accordance with job specifications.
- 2.3 Solvents are handled and stored in accordance with MSDS.

Outcome 3

Conduct structural repairs to antique wooden furniture.

Performance criteria

3.1 Parts to be repaired are disassembled in accordance with job specifications.

- 3.2 Replacement components and materials are selected in accordance with job specifications.
- 3.3 Component joints are cleaned ready for reassembly.
- 3.4 Broken components are repaired or replaced in accordance with job specifications.
- 3.5 Components are clamped into position and secured in accordance with job specifications.

Outcome 4

Conduct surface repairs to antique wooden furniture in preparation for finishing.

Performance criteria

4.1 Any surface defects are repaired in accordance with job specifications.

Range veneers – bubbles, splits; timber – dents, bruises, watermarks.

- 4.2 Surface of wood is sanded down in preparation for finishing in accordance with job specifications.
- 4.3 Type of finish and method of application is explained in accordance with job specifications.
- 4.4 Work area is left clean, clear, and safe.
