2 Definitions

Maintenance work – scheduled maintenance activity such as servicing, alignment, adjustment, condition monitoring, leak detection, replacement of components. Workplace procedures – procedures used by the organisation carrying out the work and applicable to the tasks being carried out. Examples are – standard operating procedures, safety procedures, equipment operating procedures, codes of practice, quality management practices and standards, procedures to comply with legislative and local body requirements.

3 Timeframe

All activities are expected to be completed within commercially acceptable timeframes.

Outcomes and performance criteria

Outcome 1

Prepare for maintenance of mechanical equipment.

Range three jobs.

Performance criteria

1.1 Normal operating performance of the equipment is determined.

Range examples are – product quality variation, vibration, machine noise,

processing time, temperature, power consumption.

1.2 Work is planned in accordance with maintenance requirements and workplace procedures.

Range examples are – maintenance duration, maintenance schedule,

work schedule or downtime restrictions, resources required,

specialist tools.

- 1.3 Stakeholders likely to be affected by the maintenance are consulted to ensure the work is coordinated effectively.
- 1.4 Hazards are identified and managed, and, where appropriate, shutdown procedures are ascertained and initiated in accordance with workplace procedures.

Outcome 2

Maintain mechanical equipment.

Range jobs from outcome 1.

Performance criteria

- 2.1 Equipment is maintained and recommissioned in accordance with maintenance work plan.
- 2.2 Affected stakeholders are notified of the maintenance work completion.
- 2.3 Maintenance records are updated in accordance with workplace procedures.

Range may include suggestions for improvements or modifications, future

maintenance frequency adjustment.
