Outcomes and performance criteria

Outcome 1

Identify and resolve technical requirements for live outside broadcast of a planned event.

Range requirements for two live events is required.

Performance criteria

1.1 Identify equipment requirements and their use for live broadcast.

Range may include but are not limited to – microphones, headpieces, earpieces;
evidence of 10 required.

1.2 Identify personnel and their responsibilities for live broadcast.

Range roles may include but are not limited to – director, announcer, manager(s), technician (studio, production), crew (stage, camera), media, security.

1.3 Identify potential technical issues and resolve for live broadcast.

Range testing links to studio, co-ordinating with site managers, sound technicians, other broadcasters, timings, wiring and/or cabling of cameras and/or lighting and/or sound systems.

1.4 Identify environmental and communication issues and resolve for live broadcast.

Range may include but are not limited to – location, logistics, cell-phone coverage, weather conditions, signal interference; radio frequency, makeup;
evidence of three is required.
