Emergency services can include but is not limited to – the New Zealand Fire Service, rural fire authorities, local airport rescue fire service providers, local New Zealand Defence fire brigades, local industrial fire brigades, New Zealand Police, Civil Defence Emergency Management Groups (local authorities), ambulance providers, urban search and rescue, and local community rescue teams. Fire and emergency agency's requirements refer to policies, procedures and supporting documentation on safety and operations set down by each fire and emergency agency employer or host organisation.

3 Assessment against all outcomes must be in accordance with the fire and emergency agency's requirements.

# Outcomes and performance criteria

## **Outcome 1**

Demonstrate knowledge of the command and control structures of the candidate's own fire and emergency agency's employer or host organisation.

## Performance criteria

1.1 Command and control structure for the candidate's own fire and emergency agency's employer or host organisation is explained.
