Performance criteria

- 1.1 Potential sources of ignition are identified.

- 1.2 Hazards are assessed.
 - Range fuel type, fuel load, flammability, difficulty of fire protection, detection, suppression.
- 1.3 Risks to people and property from fire at the location are identified.
 - Range environmental factors, industrial processes, occupancy, use.
- 1.4 Availability of resources to deal with fire danger at the location is assessed and determined.

Outcome 2

Devise strategies for the mitigation of fire risks and hazards.

Performance criteria

- 2.1 Firefighting response strategy is devised from all available data.
- 2.2 Resources required to implement the strategy are identified and determined.
 - Range fire appliance numbers and types, fire and rescue equipment, fire and rescue personnel, supplies of water and additives, access, input from other agencies, agreements made with other authorities pursuant to legislation.
