- 1.3 Explain the importance of food choices in terms of energy and activity requirements.
- 1.4 Describe how the weather impacts preparation for the outdoor activity.

Range sun, rain, snow, wind.

- 1.5 Describe weather information for the activity date and location.
- 1.6 Identify hazards and strategies to manage these.

Range one hazard relating to each of the following – environmental, people, equipment.

#### Outcome 2

Demonstrate knowledge of the location of an outdoor activity.

### Performance criteria

- 2.1 Explain the suitability of the location or route for the group and planned activity.
- 2.2 Identify key activity location points on a map.

Range may include but is not limited to – access roads, start and end points, rest stops, camp site, contingency route.
