Current industry good practice means the range of actions currently accepted within the adventure and outdoor sector to manage the risk of harm to staff, participants, and others.

Outcome 1

Work with others to plan an outdoor activity for a group of school students.

Performance criteria

1.1 Describe the outdoor activity and intended outcomes within a plan.

Range must include but is not limited to – activity, time required,

appropriateness for the group, outcomes hoping to achieve from

doing the activity.

- 1.2 List personal and group gear required for the outdoor activity.
- 1.3 Select a suitable location for the intended outdoor activity.
- 1.4 Identify hazards for the outdoor activity and location, and develop strategies to manage these.

Outcome 2

Work with others to lead an outdoor activity for a group of school students.

Performance criteria

2.1 Use effective communication throughout the outdoor activity.

Range throughout the activity includes but is not limited to – activity

briefing, giving instructions, providing feedback.

- 2.2 Apply strategies to manage safety of the group during the outdoor activity.
- 2.3 Apply leadership behaviours and group management strategies during the outdoor activity.
- 2.4 Role model inclusive behaviours during the outdoor activity.

Range providing support, active listening, engaging with all group

members, respect for difference (culture, ideas, ability).

Outcome 3

Evaluate own leadership of the outdoor activity.

Performance criteria

- 3.1 Gather, consider and incorporate feedback from participants and supervisor into self-evaluation.
- 3.2 Evaluate personal performance to identify strengths and areas for improvement.
