Explanatory notes

1 Definitions

The *nominated child* is defined as between 6 months and 12 years and may be set by the assessor or negotiated between the assessor and the candidate. Data about the child should include but is not limited to – age, sex, size, activities.

A *process* is a number of related techniques or a planned sequence, or a systematic series of actions.

A *technique* is a single activity such as marking a hem, threading a needle, marking fabric.

Wearable finish is the condition of a completed garment. Specific requirements may be set by the assessor or can be negotiated between the assessor and the candidate. These may include but are not limited to – choice of processes to meet requirements of end use; processes completed to appropriate standards which may relate to purpose or use of garment, fabric selected, ease or difficulty of pattern and/or style of garment; fit; pressing and appearance.

- 2 Method of investigation must comply with the requirements of the Privacy Act 1993.
- Learning and assessment activities carried out in relation to this unit standard must be conducted in a manner that is consistent with the Health and Safety in Employment Act 1992.

Outcomes and evidence requirements

Outcome 1

Describe requirements of clothing for children.

Evidence requirements

- 1.1 Description identifies design features of children's clothing in terms of safety and comfort.
- 1.2 Description identifies the choice of fabric for children's clothing in terms of safety, ease of care, and durability.

Outcome 2

Choose design and fabric for a garment for a nominated child.

Evidence requirements

- 2.1 The garment design is appropriate for the age and body shape of the nominated child and the end use of the garment.
- 2.2 The fabric choice meets design, safety, and end use requirements.

Outcome 3

Construct the garment for the child.

Evidence requirements

- 3.1 The construction processes and techniques used match the design and end use requirements.
- 3.2 The garment is constructed to a wearable finish, and meets the requirements of safety and end use.
- 3.3 The evaluation identifies any improvements that could be made in further children's clothing construction, or justifies not making any changes where improvements are not required.
