Guidance Information

- 1 Sociology is the rigorous and methodical study of society. Sociologists investigate the structure of groups, organisations, and societies, and how people interact in these contexts.
- 2 This unit standard can be awarded with an *Achieved*, *Merit*, or *Excellence* grade as specified below.

Evaluate a social structure means to form a critical opinion, based on reason and evidence, of a social structure in terms of its key aspects and of its influence on individuals and on society. The evaluation could include a consideration of Māori and/or Pasifika context(s).

Evaluate a social structure in detail means to undertake an informed and coherent evaluation of the social structure. Features of an informed and coherent evaluation may include:

- explaining key aspects of the social structure;
- explaining the extent of the influence of the social structure;
- recognising variations of the social structure across time;
- recognising variations of the social structure across place.

Conclusions must be drawn and supported with appropriate evidence and examples.

Comprehensively evaluate a social structure means to undertake an insightful evaluation of the social structure. Features of an insightful evaluation may include:

- demonstrating a comprehensive understanding of a social structure and its key aspects;
- showing clear understanding of the influence of the social structure on society;

• illustrating how and why the social structure has changed or stayed the same. Conclusions must be drawn and supported with a comprehensive range of appropriate evidence and examples.

- 3 Social structures shape identities and social interactions. They may include, but are not limited to, ethnicity, gender, age, and class.
