Guidance Information

This standard is for those beginning in the field of research. There is, therefore, an assumption that candidates will be working within a specific research methodology and have evidence of a research proposal approved by an organisational ethics committee. It is one of four standards that provide a comprehensive package for people wanting to demonstrate knowledge of research, apply that knowledge to a research project and undertake a significant piece of research. The other three standards are: Unit 9188, Demonstrate knowledge of approaches to research in education; Unit 9189, Evaluate and interpret research reports in education; and Unit 9192, Demonstrate knowledge of ethics in research in education.

2 Definitions

Organisational requirements refer to the policies, procedures, and reporting requirements of the provider, client organisation and/or standard setting body. Research methodology is a theory and analysis of how research does or should proceed, examples are: experimental, constructivist, action research, post-structural. Research techniques often referred to as research methods, which may be qualitative and/or quantitative refer to a way of proceeding in gathering evidence such as listening or interviewing informants, observing behaviour, or examining historical traces and records.

2 Literature includes but is not limited to: research papers; journals of relevant professional bodies; specialist academic publications including textbooks, databases, and discussion papers; proceedings of conferences, seminars, and workshops; and local, national, and international interest groups. These include but are not limited to: New Zealand, Australian, European and North American sources.

- 1.7 Research problems and/or questions are addressed by the research.
- 1.8 Conclusions are supported by the research data.
- 1.9 Recommendations are made that can be supported in terms of the implications of the research undertaken and benefit to the situational context in which they will be applied.

Outcome 2

Present and report on research in education.

Range must relate to the research undertaken in outcome 1.

Performance criteria

- 2.1 Limitations of the research are clarified in accordance with relevant organisational requirements.
- 2.2 Presentation of research is in accordance with organisational requirements and scholarly conventions for research reporting.
