Targeted review of qualifications – what is it?

A targeted review of qualifications at levels 1-6 was undertaken during 2009 which identified:

- qualification system was not understood by learners, parents, employers and others
- too many qualifications and duplication
- pathways to further education and employment not clear
- high cost of developing qualifications



Targeted review of Qualifications

Led to the most significant changes to the qualifications system since the National Qualifications Framework was established in the early 1990s

Changes include:

- Simplifying the qualifications system-New Zealand Qualifications Framework
- Ensuring qualifications are fit-for-purpose and relevant
- Reducing the number of qualifications by removing duplication and proliferation



New Zealand qualifications - what has changed?

Since late 2010 New Zealand qualifications have been replacing local provider and National qualifications at levels 1 – 6

- Qualifications based on industry or community workforce **needs**
- Clear and structured graduate **outcomes**
- Identified education and employment **pathways**
- Qualifications are developed **collaboratively**
- **Flexible** programmes to meet learner needs



What happens in a review?

Pre-work

- Gather information to determine sector workforce needs and skills
- Stakeholder Profile
- Determine governance and working structures

Review phase 1

- Prepare and confirm a revised map or ‘suite of qualifications’
- Prepare new qualifications for pre-approval – to be “good enough”
- Report on learning and the “story” of the decisions made to NZQA

Review phase 2

- Complete qualification development



What a new qualification looks like

- Qualification details e.g. Title, type, level, credits and NZSCeD etc
- Strategic Purpose Statement
- Outcome Statement e.g. Graduate profile, education and employment pathways
- Specification
 - ensures there is sufficient information for programme developers to meet the graduate profile
 - differentiates mandatory and optional conditions for qualification and/or individual outcomes

Māori Studies and Custom Qualifications

A summary of the changes includes:

Addition of 7 new qualifications: The proposed additional qualifications include:

- 2 qualifications from Christchurch Polytechnic of Technology that focus on Māori studies and Te Reo Māori (unless already included in the Te Reo Māori review)
- 2 qualifications from Te Wānanga o Aotearoa that focus on Rongoa (unless included in the Hauora review)
- 1 qualification from Te Wānanga o Raukawa that focuses on Rongoa (unless included in the Hauora review)
- 1 qualification from Eastern Institute of Technology that focuses on Māori Studies (previously missed)
- 1 qualification from People Potential Limited (Private Training Establishment not previously listed) that focuses on tikanga Māori and computing skills (unless included in the Computing review. This qualification is similar to Waiariki Institute of Technology's Certificate in Māori Studies - Introductory).

Removal of 11 qualifications: The proposed removal of qualifications include:

- Northtec's Te Pokaitahi Nga Mahi Tu Taua (to be included in the Toi review)
- Te Wānanga o Aotearoa's Certificate in Tū Taua (to be included in the Toi review)
- NZQA Māori Qualifications Service's National Certificate in Governance of Māori Authorities (included in the Māori Governance review).
- 2 qualifications from Waiariki Institute of Technology (which are no longer in use)
- 6 Qualifications from Te Wānanga o Raukawa

Matauranga Maori Quality Assurance Mark



- Indicates:
 - All requirements clearly met
 - Highly likely to:
 - » meet identified needs
 - » advance the use of matauranga Maori
 - Provider capability

Roles and Responsibilities

Governance Group

- Provides strategic direction, guidance and project overview of the review process. It is a forum for decision making.
- Ensure that the suite of qualifications are based on current and future needs of iwi, hapū, hapori and stakeholders.

Working Groups

- Provide technical input in the qualification development
- To develop the qualifications based on the needs and feedback from stakeholders
- Communication out to wider stakeholders
