Please note that only the nominated qualification(s) will be assessed, not the supporting documents.**
- The IQA provides an assessment of which level your overseas qualification compares to on the New Zealand Qualifications Framework (NZQF), and, where possible, to a New Zealand qualification type. **The Skill Shortage List may also list other documents that need to be provided to Immigration New Zealand** (for example, a letter from Engineering New Zealand for some engineering occupations). **NZQA does not provide these additional documents;** you will need to contact the relevant authorities and apply to them directly.
