What is the computer science concept?

How is the concept used?

The concept is used to detect and repair any errors in data. The type of data that can be protected by this method includes data on hard disks, data that is being transmitted across networks, wired and wireless. It can also be used to prevent human error when entering credit card numbers, bank accounts or ISBN book numbers. The concept of error control is designed to ensure that data is correct and if there are any errors in the data, these can be detected to prevent further problems, such as valuable information being incorrect or lost, and decisions being made based on false data. It can also be used to prevent human error when entering codes, such as credit details or bank account numbers, online.

### QUESTION THREE

How has the concept been (or could be) applied to address an opportunity?

One example is the use of barcodes on products in shops and supermarkets. When a barcode is scanned, the price is automatically calculated and added to the amount the customer must pay. This is a very quick and efficient way to move people through a long line at checkout in a busy supermarket.

Another benefit is that barcode scanning will also update stock levels in real time. This is fine when the barcodes are being read clearly by the scanner, but what happens if they are damaged and the scanner cannot read them clearly? How can they be entered manually if a barcode just has lines on it?

This is where error-control coding provides a manual backup to an automated process. Each barcode has a global trade item number or GTIN. This number is printed on each barcode for situations where the barcode cannot be read by a scanner. In this case, the GTIN number can be entered manually. But what happens if the person on the checkout enters the number incorrectly? This would have two effects and could mean the

customer is charged more or less for a product, and if the wrong product is entered as sold, then the stock levels would also be incorrect.

The best way to prevent this problem and ensure both the sale date and stock-level data are correct is by a method of error control coding known as check digits. A check digit is added to the end of a GTIN number and is calculated using all the other numbers. In the case of a GTIN number that is written at the bottom of a barcode, there are 13 numbers and the 13th is calculated using the first 12 numbers. This means that if any of the numbers are entered incorrectly, the check number will be incorrect, and the error will be spotted by the computer system. Error-control coding will identify an error and prevent incorrect data being entered. This could save businesses thousands of dollars, as it ensures all sales are recorded correctly and stock levels are up to date.

#### QUESTION FOUR

Which mechanisms shape the concept?

The algorithm used to create GTIN numbers works like this:

Using the first 12 numbers in the GTIN, multiply every second digit by 3 and every other digit by 1. These numbers are then all added up to make the total or sum. The check sum digit is found by working out a number that you would have to add to the sum to make it a multiple of 10. For example, if the total is 117, then the check digit would be 3. This can also be known as a 'parity bit' or an extra bit of data that can be used to check if the original data is correct.

#### QUESTION FIVE

Explain how the concept relates to at least one of the following:

- ethical issues
- social impact
- sustainability
- human factors
- future-proofing.

Ethical issues:

Error-control coding can ensure data is accurate and correct, but it can also prevent fraud. Without some form of error-control coding, people could potentially 'guess' credit numbers and use them to purchase goods illegally online. Thus, advanced error-control systems not only prevent errors, but can also be a form of internet security for financial transactions.

Social impact:

The use of error-control coding systems means people will feel more secure using credit cards and online banking, as they know there is less room for error when making purchases and entering data online. For business owners, it can provide more accurate and reliable data and reduce costs.

Human factors:

One of the key benefits of error-control coding is to eliminate errors by humans. When entering data, humans can potentially type incorrect numbers or type numbers in the wrong sequence. An error-control algorithm that creates a check sum or parity bit drastically reduces the chances of human error. It is important to note it will never be 100% accurate.

**QUESTION SIX**

How does the concept relate to key issues or problems?

Accurate data and information are critical for business and governments. Automated systems, such as self-driving cars, need accurate data to perform safely. Governments use data to make economic predications and scientists use data to predict weather patterns and droughts, which can have a major effect on farming and world food supplies. For these reasons, error-control coding is critical to ensure important decisions can be made with accurate data. While more and more of this data is input automatically by sensors and scanners, there are still some occasions when data is input by humans and there is, therefore, the potential for error. Error-control coding is, therefore, critical to prevent human error when inputting data.

In banking, error-control coding is particularly important to ensure people can buy items online and pay bills or transfer money safely. Without error-control coding, mistakes such as typing in the wrong bank account number would not be spotted immediately. This could lead to people not being paid, or money being paid to the wrong person or institution.
