<p>Key requirements for <b>Achievement</b>:</p> <p>The student makes meaning of written and/or visual Samoan by responding in their choice of English, Te Reo Māori and/or Samoan to the information, ideas, and opinions about the events, people, places and experiences of the Samoan read and/or viewed.</p> <p>This involves:</p> <ul style="list-style-type: none"> <li>• showing general understanding</li> <li>• recognising basic detail</li> <li>• suppling answers using some evidence from the text</li> <li>• demonstrating basic knowledge of language at level 7 of the curriculum.</li> </ul>	<p>Key requirements for <b>Merit</b>:</p> <p>The student selects relevant information, ideas, and opinions from the texts and communicates them unambiguously.</p> <p>This involves:</p> <ul style="list-style-type: none"> <li>• demonstrating a good level of understanding of the text</li> <li>• using detail from the text to support answers</li> <li>• giving responses that develop and link information to communicate some or most of the meaning</li> <li>• giving personal responses but not expanding on the text by drawing credible conclusions or making valid generalisations.</li> </ul>	<p>Key requirements for <b>Excellence</b>:</p> <p>The student expands on relevant information, ideas, and opinions from the texts with supporting detail; and shows understanding of the implied meanings or conclusions within the text.</p> <p>This involves:</p> <ul style="list-style-type: none"> <li>• demonstrating accurate understanding of lexical items and their contribution to the meaning or purpose of the texts</li> <li>• thoroughly understanding most of the inferences and implied meanings</li> <li>• selecting relevant details in the text and expanding on them by drawing conclusions and making generalisations</li> <li>• making links to create fully developed and justified answers.</li> </ul>
