- describing how hauora is affected by an activity, using a model of health, including supporting evidence
- describing how the different parts of the model interconnect.

- explaining why hauora is affected by an activity, using a model of health, including supporting evidence
- explaining why the different parts of the model interconnect.

Evaluate hauora in a health-related context through the application of a model of health involves:

- drawing conclusions about how hauora is affected by an activity in the short and long-term, with reference to a model of health, including supporting evidence.
- 2 The *application of a model of health* must occur in any of the Key Areas of Learning:
- Food and Nutrition
 - Mental Health
 - Relationships and Sexuality.
- 3 For the purpose of this achievement standard, the explanation of why hauora is affected by an activity must use a model of health. *Hauora* is a Māori philosophy of holistic wellbeing grounded in bodies of mātauranga unique to Aotearoa New Zealand.
- 4 A *model of health* is a guide to understanding how areas of health and wellbeing are affected by a variety of aspects.

Examples include:

- Te Wheke
 - Te Whare Tapa Whā
 - Fonua
 - Fonofale.
- 5 An *activity* refers to an action or experience that can result in a change to the hauora of an individual, community, or society. A model of health can be applied to reflect on the changes for those involved. Ākonga may refer to an activity that they have participated in, or they may refer to an activity that others have experienced. The activity and the reflection can relate to one or more Key Areas of Learning.
