### Guidance Information

- 1 All tasks must be carried out in accordance with enterprise procedures.
- 2 Definition  
*Enterprise procedures* – procedures used by the organisation carrying out the work and applicable to the tasks being carried out. Examples are – standard operating procedures, safety procedures, equipment operating procedures, codes of practice, quality management practices and standards, procedures to comply with legislative and local body requirements.

### Outcomes and performance criteria

#### Outcome 1

Prepare to repair or overhaul aircraft crew escape system components.

#### Performance criteria

- 1.1 Task is determined by reviewing maintenance documentation and manuals.
- 1.2 Component serial and part numbers are matched with documentation.
- 1.3 Resources are obtained and checked for serviceability or status.

Range may include but is not limited to – manuals, materials, tools, equipment, safety equipment, work area selected for task, prepared and cleaned.

1.4 Component defects are located prior to disassembly.

Range any explosives removed, components inspected, troubleshooting carried out, economics of carrying out repair or overhaul assessed.

## Outcome 2

Repair or overhaul aircraft crew escape system components.

### Performance criteria

2.1 Components are disassembled.

Range cleaned, inspected, labelled, preserved, segregated.

2.2 Defects found during disassembly are reported and/or recorded.

2.3 Rectification action is determined, confirmed, and recorded.

Range repair, overhaul, replace, modify, adjust, scrap; confirmation of action to be taken obtained from supervisor, action to be taken recorded.

2.4 Replacement parts are procured and verified as authentic and serviceable.

Range identify, inspect.

2.5 Crew escape system component defects are rectified.

Range systems – ejection seat, command and initiator.

2.6 Components are assembled.

2.7 Components are tested and adjusted.

Range functionally tested, calibrated and/or adjusted, adjustments and/or performance recorded.

2.8 Supervisory inspections are obtained.

## Outcome 3

Complete tasks related to the repair or overhaul of aircraft crew escape system components.

### Performance criteria

3.1 Components are prepared.

Range may include but is not limited to – use, storage, transit, locked, inhibited, blanked, packed.

3.2 Resources are checked for serviceability and returned to service or storage.

Range may include but is not limited to – manuals, tools, equipment, safety equipment.

3.3 Leftover parts and materials are disposed of in.

Range may include but is not limited to – serviceable, unserviceable, surplus, waste, scrap, hazardous.

3.4 Documentation is completed.

Range may include but is not limited to – labels, work orders, logbooks, shelf-life requirements recorded, certification obtained.

3.5 Work area is left in a clean and tidy state.
