- 2 Definitions

Job prescriptions are those given to the operator prior to undertaking a job. They may include site safety instructions, mapping information, contract drawings, and written memos.

Wāhi tapu refers to a place sacred to Māori in the traditional, spiritual, religious, ritual or mythical sense. This may include pā sites, urupā (cemeteries), wāhi pakanga (battle grounds), maunga (mountains), rākau (trees), geothermal springs, wetlands, rivers, estuaries, coastal areas.

Outcomes and performance criteria

Outcome 1

Describe the purpose and requirements of forestry earthworks job prescriptions.

Performance criteria

- 1.1 The purpose of forestry earthworks job prescriptions is described.

Range includes but is not limited to – compliance, meeting client expectations.

- 1.2 Consequences of failing to meet the requirements of forestry earthworks job prescriptions are described.

Outcome 2

Interpret forestry earthworks job prescriptions.

Range evidence must include – one exemplar job prescription, one actual job prescription of a candidate's current or past work site.

Performance criteria

- 2.1 Responsibilities and requirements for the job are identified in job prescriptions.

Range may include but is not limited to – consented activities, permitted activities, safety plan and types of hazards, work instruction, site visit.

- 2.2 Earthworks to be achieved are identified in terms of type, location, construction method, and quality expectations.

Range quality expectations may include but are not limited to – design, environmental considerations, compaction, materials, gradients.

- 2.3 Mapping information is used to confirm orientation on site, job location and site features.

Range information may include but is not limited to – ridges, bluffs, water courses, boundaries, vegetation type(s), roads and their types, landings, historic sites, wāhi tapu, environmental areas, stocked areas, contour lines.

- 2.4 Distances specified within the job prescriptions are confirmed.
