- 2.2 Purpose of each part is described.
- 2.3 Method of attachment for each part is identified.

Outcome 3

Identify seatbelt pretensioners and SRS component precautions.

Performance criteria

- 3.1 Precautions to take when working around seatbelt pretensioners and SRS components are identified.
