- 1 Sociology is the rigorous and methodical study of society. Sociologists investigate the structure of groups, organisations, and societies, and how people interact in these contexts.
- 2 This unit standard can be awarded with an *Achieved*, *Merit*, or *Excellence* grade as specified below.

*Describe a social process* means to describe a social process in terms of its influence on individuals and society. The description could include a consideration of Māori and/or Pasifika context(s).

*Describe a social process in detail* means to identify and describe the interaction of various social structures, institutions, groups and individuals involved in the social process. The description should be supported with appropriate evidence and examples.

*Comprehensively describe a social process* means to describe in-depth a social process, including the role norms and values play in shaping the process. The description must be supported with a comprehensive range of appropriate evidence and examples.

- 3 **Definition**  
Social processes are the means through which individual and social identities and relationships are shaped. They may include but are not limited to socialisation, stratification, and globalisation.
