Outcomes and performance criteria

Outcome 1

Prepare to form aeronautical sheet metal items by rubber pressing.

Performance criteria

- 1.1 Task is determined by reviewing maintenance documentation and enterprise procedures.
- 1.2 Work area is prepared, and resources are obtained and checked for serviceability or status.

Range may include but is not limited to – publications, tools, materials, equipment, safety equipment.

Outcome 2

Form aeronautical sheet metal items by rubber pressing.

Performance criteria

- 2.1 Material is cut to meet specifications.
Range marking out, cutting.
- 2.2 Form blocks are centrally located in press.
- 2.3 Material is located in form blocks to ensure final shape meets specifications.
- 2.4 Item is pressed to meet specifications.
- 2.5 Any defects are rectified.
- 2.6 Inspections are obtained.

Outcome 3

Carry out task completion activities.

Performance criteria

- 3.1 Item is prepared for use, storage, or transit.
- 3.2 Completion activities specific to the task and work area are carried out.
Range may include but are not limited to – tool control, cleanliness, tidiness, return of publications, preparation for next activity, return of aircraft and systems to normal.
- 3.3 Leftover items, parts, and materials are disposed of.
Range may include but is not limited to – serviceable, unserviceable, surplus, waste, scrap.
- 3.4 Documentation is completed.
