Outcome 1

Check feed ingredient supplies and identify feed quality problems.

Performance criteria

- 1.1 Check feed ingredient supplies for quantity available.
- 1.2 Check delivery docket for accuracy.
- 1.3 Report problems with feed quality or delivered feed ingredients.
- 1.4 Keep records of feed quality and quantity.

Outcome 2

Check and maintain mill and mix plant before use.

Performance criteria

- 2.1 Check mill and mix plant for contamination and residues.
- 2.2 Resolve contamination or residue problems.
- 2.3 Lubricate mill and mix plant.

Outcome 3

Mill and mix feeds.

Performance criteria

- 3.1 Mill, and measure grain in accordance with the feed formulation.
- 3.2 Measure and transfer feed ingredients and feed additives in accordance with the feed formulation.
- 3.3 Mix ingredients in accordance with workplace procedures.
- 3.4 Transfer mixed feed to feed silo in accordance with workplace procedures.
