Guidance Information

1 Definition

Industry procedures refer to all workplace requirements in operation in casinos.

These may include, but are not limited to, relevant statutory and regulatory requirements, minimum operating standards, Gazetted Rules, licence conditions, and procedures described in training courses for the conduct of games, as approved by the Department of Internal Affairs or the Gambling Commission. Industry procedures may also include procedures specific to an enterprise involved in the casino gaming industry. These additional enterprise procedures may include quality assurance, documentation, security, communications, health and safety, and personal behaviour.

- 2 The Gambling Act 2003 is the main piece of legislation relevant to this unit standard, together with any associated legislation and/or regulations.

Outcomes and performance criteria

Outcome 1

Interpret and apply terms commonly used in the game of craps.

Range terms commonly used in the game of craps may include but are not limited to – any seven, betting right, betting wrong, any craps, cold dice, craps out, easy way, come out roll, house edge, rails.

Performance criteria

- 1.1 Terms commonly used in the game of craps are interpreted in accordance with the gazetted rules.
- 1.2 Terms commonly used in the game of craps are applied in accordance with the gazetted rules.

Outcome 2

Open the table for the game of craps.

Performance criteria

- 2.1 Dice are received and inspected in accordance with industry procedures.
- 2.2 Chip float is opened and balanced in accordance with industry procedures.
- 2.3 Variances in chip float are dealt with in accordance with industry procedures.

Outcome 3

Use the dice and deal the game of craps.

Performance criteria

- 3.1 The dice are retained and served in accordance with industry procedures.
- 3.2 The dice are inspected to ensure they comply with industry procedures.
- 3.3 The throwing of the dice is monitored, and any irregularities are addressed in accordance with industry procedures.
- 3.4 The chips are counted and collected in accordance with industry procedures.

Range may include but is not limited to – cash information, chip information, authorisation levels, chip purchase vouchers.

Outcome 4

Apply rules and procedures for wagers for the game of craps.

Range permissible wagers may include but are not limited to – pass bet, don't pass bet, come bet, don't come bet, odds on the pass bet, behind the don't pass bet, odds on the come bet, behind the don't come bet, place bet to win, buy bet, lay bet, hard way, big six, big eight, field bet, any seven, any craps, craps two, craps three, craps twelve, 11 in one roll, horn bet, horn high bet, world bet.

Performance criteria

- 4.1 Wagers placed are accepted and/or refused in accordance with industry procedures.

- 4.2 Winning, losing, and stand-off wagers are determined in accordance with industry procedures.
- 4.3 Losing and stand-off wagers are actioned in accordance with industry procedures.

Outcome 5

Apply rules and procedures for payouts for the game of craps.

Range permissible wagers may include but are not limited to – pass bet, don't pass bet, come bet, don't come bet, odds on the pass bet, behind the don't pass bet, odds on the come bet, behind the don't come bet, place bet to win, buy bet, lay bet, hard way, big six, big eight, field bet, any seven, any craps, craps two, craps three, craps twelve, 11 in one roll, horn bet, horn high bet, world bet.

Performance criteria

- 5.1 Winning wagers are calculated at the odds listed in the gazetted rules.
- 5.2 Winning wagers are paid out in accordance with industry procedures.

Outcome 6

Deal with irregularities and non-compliance in the game of craps.

Performance criteria

- 6.1 Irregularities and non-compliance are identified in accordance with industry procedures.
- 6.2 Irregularities and non-compliance are dealt with in accordance with industry procedures.

Outcome 7

Maintain game security for the game of craps.

Performance criteria

- 7.1 Game security is maintained in accordance with industry procedures.

Outcome 8

Close the game of craps.

Performance criteria

- 8.1 Chip float is counted, and documentation completed in accordance with industry procedures.

8.2 Dice are checked and sealed in accordance with industry procedures.

8.3 Equipment is secured in accordance with industry procedures.
