- 2 *Demonstrate understanding of a dance genre or style in context* involves providing descriptions of the features and the context of the dance genre or style.

Demonstrate in-depth understanding of a dance genre or style in context involves providing explanations of the relationship between the features of the dance genre or style and its context.

Demonstrate comprehensive understanding of a dance genre or style in context involves providing detailed explanations of the significance of the context on the development and/or features of the dance genre or style.

- 3 Dance genre or style in context may include:
 - its origins
 - changing or maintaining of key features
 - the relationship between the dance genre or style and its time and place

 the effect of individual, social, cultural, geographical, political and technological influences.

Genre is a specific category of dance that has a tradition or history and is identifiable by specific characteristics, social functions and cultural contexts (eg Māori performance, ballet, contemporary dance).

Style is a subset of genre and may be associated with a particular performer, performance group, choreographer or period (eg poi, Romantic ballet, Martha Graham style).

The features of a dance genre or style typically include:

- characteristic movements
- dancers and their roles
- setting
- purpose
- status
- design elements
- clothing
- sound
- use of objects.
