Communicate in-depth understanding involves:

- explaining key ideas using supporting evidence gathered from art works and other sources

- drawing reasoned conclusions based on the information gathered.

Communicate perceptive understanding involves:

- evaluating key ideas to draw insightful conclusions based on the information gathered, and using supporting evidence gathered from art works and other sources.

- 3 *Art history topic* refers to an area of inquiry selected by the teacher or the student.

Art history topics may include but are not limited to: an art concept, issue or theme, an art movement, a selected artist, a period in art history.

- 4 *Art works* may include but are not limited to: paintings, drawings, sculptures, installations, prints, collages, architecture, handcrafted objects, film, animation, photographs, digital images, whakaairo, kōwhaiwhai, tukutuku, tapa cloth.
