Explanatory Notes

- 1 This achievement standard is derived from *The New Zealand Curriculum*, Learning Media, Ministry of Education, 2007, Level 7. - 2 *Perform a repertoire of dance* involves:
- reproducing the movements required by each dance in a series of dances
 - differentiating the timing and focus required for each dance
 - conveying aspects of the idea behind each dance.

Perform a repertoire of dance showing understanding of the stylistic requirements involves:

- clarity of movement and body shapes required for each dance in a series of dances
- varying posture appropriately for each dance in a series of dances
- differentiating and maintaining the timing, focus, and expression required for each dance
- conveying the idea, mood, or feeling of each dance.

Perform a repertoire of dance showing in-depth understanding of the stylistic requirements involves:

- displaying details of each dance in the series (eg defined hand movements, use of the breath)
- sustaining appropriate performance energy over the series of dances
- clearly communicating the underlying emotional content or concepts of each dance.

- 3 *A repertoire of dance is a series of three or more dances of the same genre. A repertoire is able to be performed on more than one occasion.*
- 4 *Stylistic requirements include the specific types of movements associated with the style, the qualities with which that movement is performed, the use of appropriate rhythms and demonstration of appropriate musicality and the communication of the underlying emotional content or concepts.*
