*Explain, with clear reasons*, will be demonstrated through giving well articulated reasons why, or why not, the selected objects may be considered as art based on evidence from the objects.

*Explain, with convincing reasons*, will be demonstrated through giving persuasive reasons why, or why not, the selected objects may be considered as art based on evidence from the selected objects.

- 3 *Objects* refer to items that may be considered as art eg items created by ‘artists’, ‘craftspeople’, ‘designers’ or produced commercially; items created in hard or soft materials; items created by hand or through mechanical or digital technologies; items which are temporary or permanent.
  - 4 *Selected objects* may include – paintings, drawings, sculptures, installations, prints, collages, architecture, handcrafted objects, film, animation, photographs, digital images, whakaairo, kowhaiwhai, tukutuku, tapa cloth.
