### Explanatory Notes

- This achievement standard is derived from *The Arts Learning Area of The New Zealand Curriculum*, Learning Media, Ministry of Education, 2007, and relates to the strands Developing Practical Knowledge, Communicating and Interpreting, Understanding the Arts in Context, and Developing Ideas for Drama Level 8. - Direct a drama performance* involves researching, analysing and translating a scripted text into a credible performance.

*Direct a drama performance skilfully* involves translating the scripted text into a cohesive and convincing performance. It involves working with competence, control, and a sense of purpose.

*Direct a drama performance effectively* involves capturing the essence of the scripted text in a compelling performance.

- 3 The research and analysis of the text for performance includes:
    - identifying the intention of the playwright
    - identifying the ideas, themes and messages within the chosen text
    - establishing the historical, geographical and social background of the text
    - considering the development of the characters and action throughout the text
    - formulating an explanation of the director's production concept.
  - 4 Translating the scripted text requires the director to facilitate the enactment of the script from 'page to stage'. This includes:
    - communicating a concept to convey the intention(s) of the play
    - casting of actors
    - developing and implementing a rehearsal schedule
    - supporting the development of the roles and dramatic action
    - guiding the production team
    - fostering a positive and co-operative working environment to enable the potential of the drama performance to be realised.
  - 5 *A drama performance* relates to a published work by a playwright that offers the opportunity for the exploration of layers of meaning and message. This could be a one act play or a full script. It is at least an extended extract of a compilation of scenes that is structured to allow consideration of the development of the drama.
