The candidate has demonstrated some understanding of the question and has utilised some evidence in support of their description, however, this is limited. There is some variation in the use of source material as evidence and the description, though accurate, is limited.			
2	A3	The candidate has identified two different reasons why people did not want an extension in pub opening hours. Although some evidence has been used in support of the description there is significant variation in its application. The question has been answered to some extent, however the level of detail is not consistent throughout.			
3	A3	A reasonable attempt has been made to describe the factors that caused the change in public opinion preceding the second referendum in 1967. Some relevant material from the sources document has been used however there is some variation regarding direct relevance to the question. The description is generally accurate though limited in its depth.
