Question number: 3

Frank Darabont used symbols to add more meaning to the setting of Shawshank prison. Darabont's timeless classic 'The Shawshank Redemption' uses the symbols of music, birds and lighting to develop Shawshank prison as a hopeless place.

Darabont who spent some time in a refugee camp in France as a child has an affinity for the prison genre. Other work he has directed such as 'The Green Mile' and tv series 'Prison Break' has his hopeless prison style. Darabont has a knack for displaying the hopelessness of being imprisoned and the hope emitted by the people entrapped.

The use of music in films is done to add suspense to a situation or show emotion. In this particular case music is used to show hope in Shawshank prison and it adds meaning to its setting as a hopeless place. The music scene is used to show hope entering a hopeless place as Andy locks himself inside the warden's office and plays Mozart's "Marriage to Figaro" over the speakers. As the music begins playing the prisoners begin to look up at the speakers with crane shots overlooking the yard. Panning low angle shots show the prisoners looking free with the blue sky above them. After some time of only music Red begins a voice over "I have no idea what those two Italian ladies were

singing about... it's like some bird flapped into our trap ~~the~~ cage and made the walls dissolve away. And ~~for~~<sup>for</sup> a moment every last man in Shawshank felt free." the music is a symbol of hope so by Andy playing it we see the not everyone in Shawshank will become hopeless ~~if they~~ and institutionalised. Music is seen as a symbol of hope again during Andy and Red's discussion at breakfast: While Red says he gave up music in prison because it made no sense Andy responds with the dialogue "~~something~~" "having something inside of you ~~to~~ you know they can't get to. Hope." the music is seen now as a source of hope for Andy and it adds meaning to the prison setting. ~~It~~ It shows not everybody will become institutionalised if they can hold onto hope.

The Birds as a symbol of freedom make an appearance in prison - ~~which is seen as~~ a setting of entrapment. Birds are constantly used in Red's voice overs like the ~~at~~ music scene where he mentions birds melting away the walls. However, they are also mentioned in regards to when Andy has escaped prison. Red's voiceover speaks of him missing Andy but he knows he was innocent and shouldn't have been there anyway. "some birds just aren't meant to be caged their colors are just too bright." referring to Andy as a bird speaks of his innocence but birds don't always fly once they leave prison. When Brooks leave Shawshank after 50 years he knows nothing of the outside world - institutionalised. When he leaves ~~the~~ the prison he goes to the park to feed the birds. While they are all caged in <sup>a midshot we see them in</sup> shadows linking to despair some of the birds are flying showing them and Brooks as hopeless. Eventhough Brooks is no longer in prison he is affected

by its institutionalisation and despair. ~~The~~ Showcasing the long-term impact that ~~the~~ Shawshank prison is a place of despair.

The symbol of lighting inside Shawshank prison is used to show the good vs evil struggle occurring inside the prison. Shawshank prison is run by the corrupt Warden Norton, we see his evil nature overshadowed by the lighting he is shown in. When the warden first appears it is out of the shadows before he addresses the inmates, using the effect of color to foreshadow his evil. The lighting ~~also~~ also shows Norton's duality as he is perceived as a Christian prison warden when really he is corrupt and runs money laundering schemes through the prison. ~~the~~ ~~the~~ Throughout the film the lighting ~~continues~~ techniques continue as he appears from the shadows when he talks to Tommy before Captain Hadley shoots him. The lighting symbol gives meaning to Shawshank as a evil place because ~~to~~ of who it is run by. The corruption Norton brings to the prison is shown by the symbol of lighting and adds a sense of evil along to the already present sense of despair that Shawshank possesses.

~~vs~~ Hope in prisons today is a constant issue as ~~we~~ we ask ourselves how do we stop inmates from becoming ~~full of~~ ~~despair~~ institutionalised. Many prisoners will one day reenter society so it is important that they come out functioning members of society. This will occur as we break the routine of prison life by integrating courses which enable skill learning. As seen in Jon Hirwins anti-depression adds "hold on to hope" ~~the~~ this message should be encouraged in prisons as well as it could be the difference

in a <sup>hopeful</sup> ~~happy~~ or despair filled life after prison.

The symbols in Frank Darabont's "The Shawshank Redemption" are used to show hope vs despair in prison. They add to the setting by making it seem full of despair or evil. Symbolism adds to Shawshank as it makes the ~~read~~ audience ~~be~~ aware of the despair inside the walls.

\* As seen in Shakespears 'Macbeth' "Whats fair is foul and foul is fair." which ~~is~~ ~~to~~ perfectly shows the prison as the warden is corrupt while Andy is actually innocent.
